What is the 340B Program?

Introduction

- A Federal Program established by Congress in 1992
- Manufacturers participate in Medicaid require to provide outpatient drugs to covered entities like HJAHC at significantly reduced price

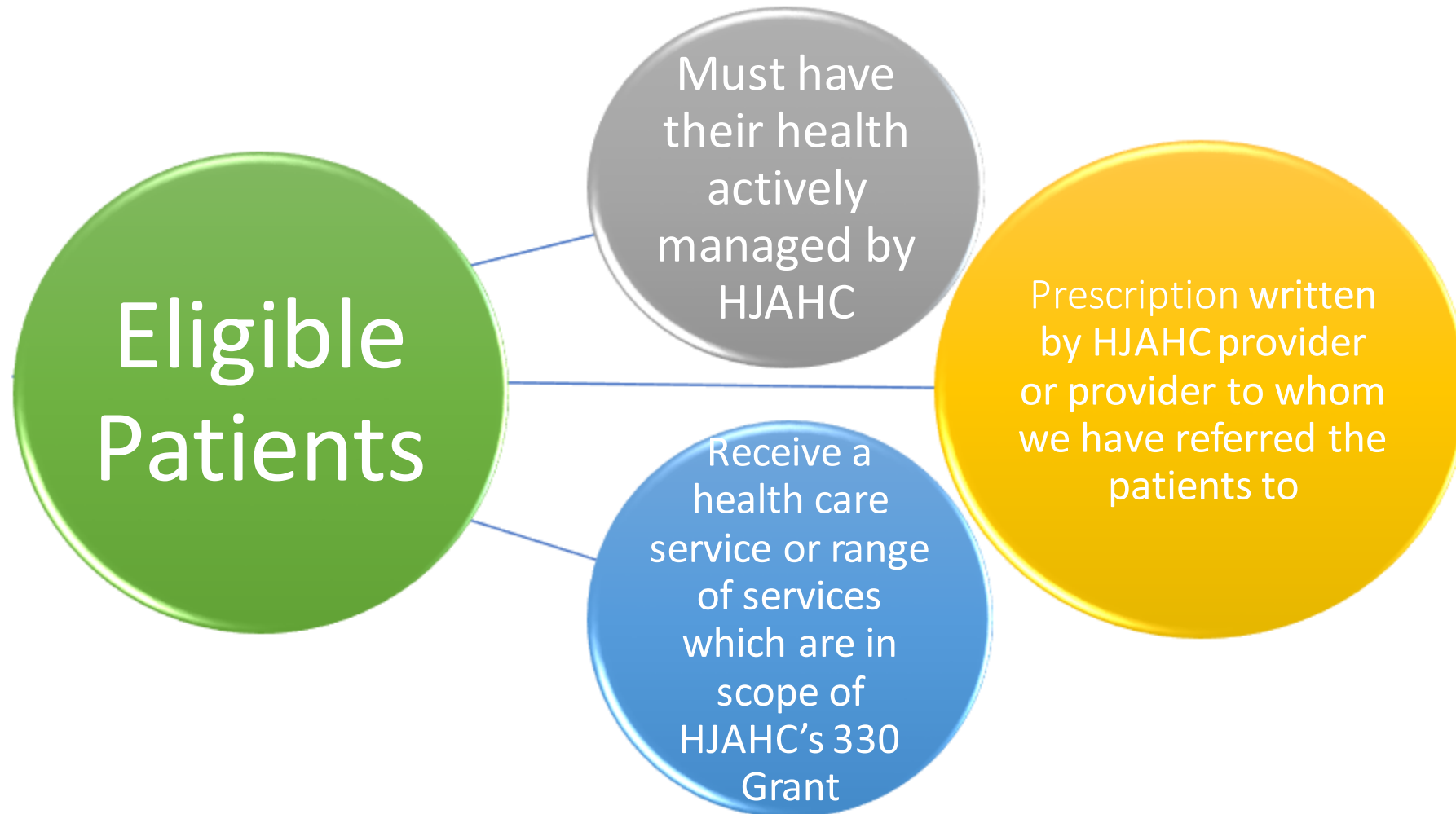

Importance of 340B Program

Medication Discount

Medication Name	Patients At or Below 100% FPL Pay if no 340B Program	Patients At or Below 100% FPL Actually Pay with 340B Program
Eliquis 5mg Tablet 60 count	$\$510.39 + \$1.00 = \$511.39$	$\$41.86 + \$1.00 = \$42.86$
Lantus solostar pen 3ml 5 count	$\$410.42 + \$1.00 = \$411.42$	$\$0.14 + \$1.00 = \$1.14$

- HJA Patient paid \$636.12 for one month supply of Eliquis at CVS Pharmacy



What is 340B Saving?

340B Savings at HJAP

Examples of 340B Saving:

Medication Name	Net Savings without 340B Program	Net Savings with 340B Program	340B Savings
Eliquis 5mg Tablet 60 count	$\$600 - \$510.39 = \$89.61$	$\$600 - \$41.86 = \$558.14$	\$468.53
Lantus solostar pen 3ml 5 count	$\$600 - \$410.42 = \$189.58$	$\$600 - \$0.14 = \$599.86$	\$410.28

Only about **30%** of HJAHC patients use HJA Pharmacy

What is 340B Saving?

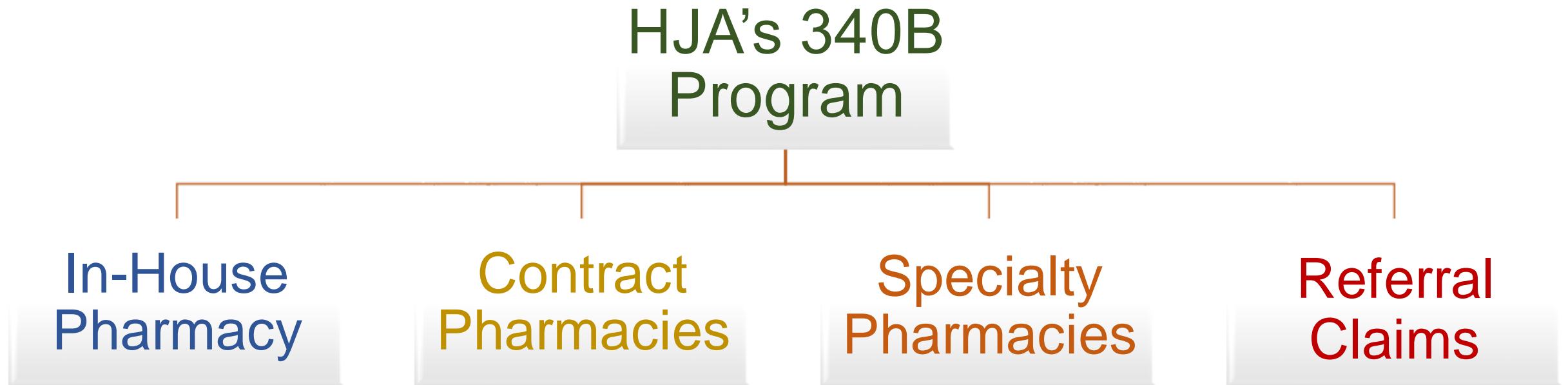

In house Pharmacy

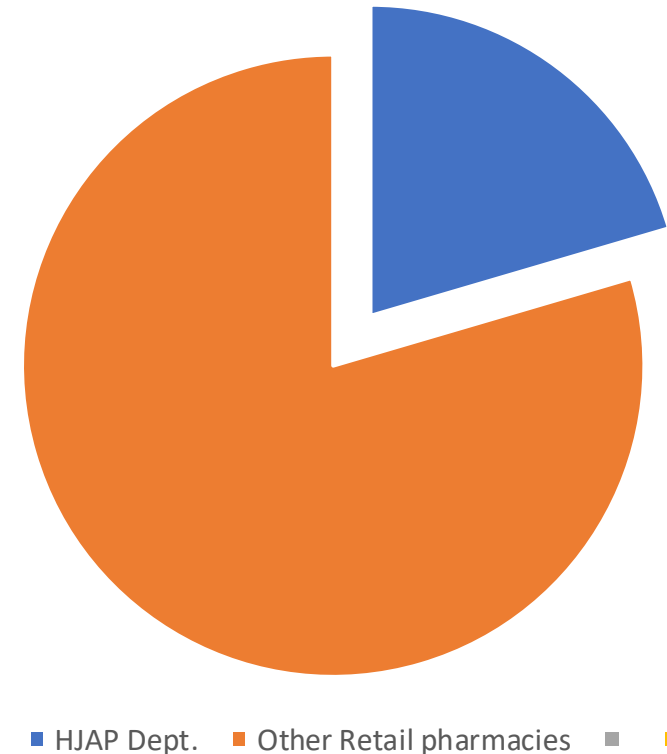
Henry J. Austin Pharmacy Department (HJAP) at Warren St.

- Opened for business in February 2016
- Owned by HJAHC
- Open-door pharmacy
 - Utilizes specialized pharmacy software capable of:
 - Billing prescriptions at regular pricing for the public
 - Applying individualized prescription discounts based on a sliding scale determined by income

In house Pharmacy

Henry J. Austin Pharmacy Department (HJAP) at Warren St.

- Only 30% of total prescribed medications from our providers are transmitted and filled at HJAP Dept.
- HJAP is currently staffed and equipped to provide services to more patients

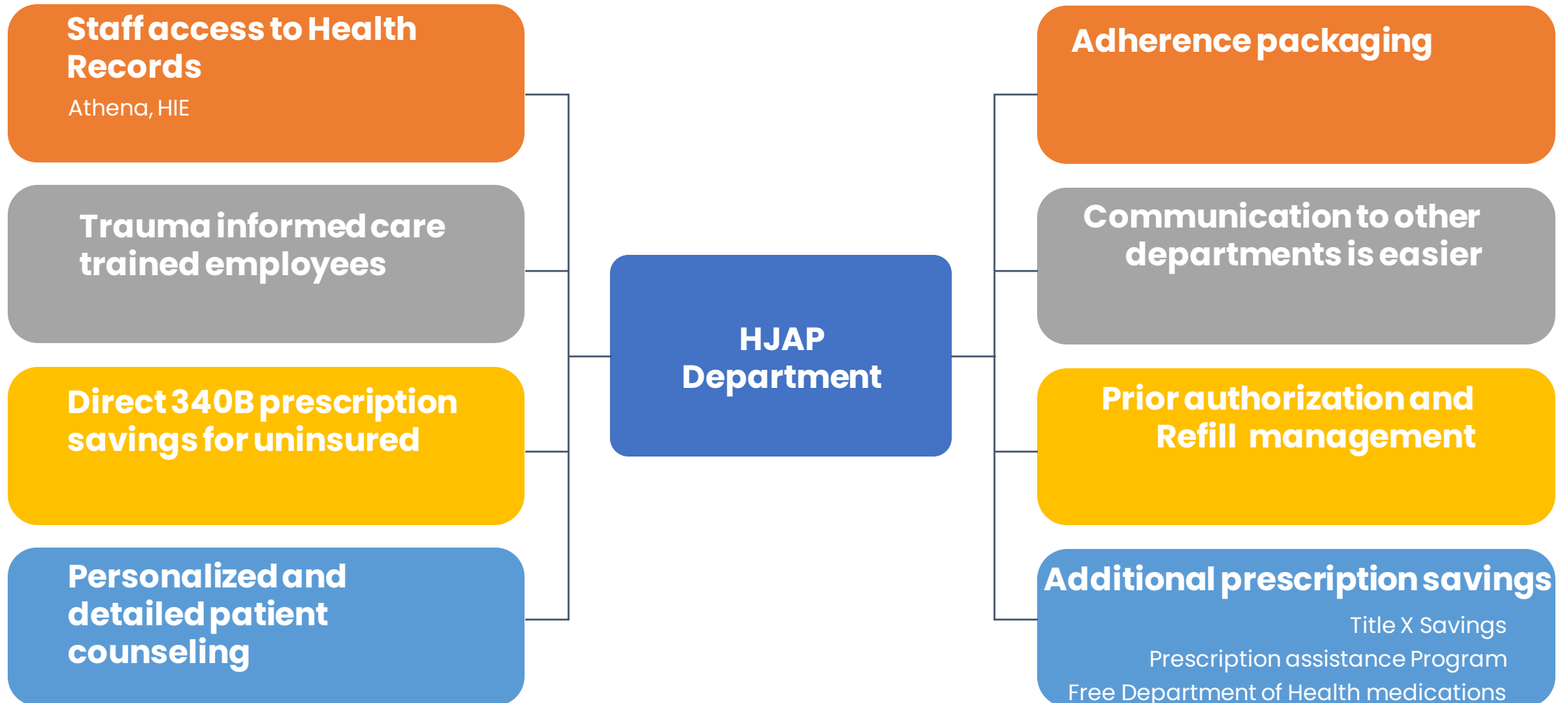

Contract/Specialty Pharmacies:

- HJA has contractual agreements with retail/independent/specialty pharmacies like CVS, Walgreens, Walmart, Westside, Ewing, Mast, Rapp's West, Episcopo's, and BioPlus.
- HJA receives a part of the profit every time HJA patients fill their medication at one of these contract pharmacies

Where do the 340B savings come from?



Contract/Specialty Pharmacies:

- No Sliding Fee Scale discount for HJA patients at contract pharmacies
- Manufacturers' contract pharmacy restrictions

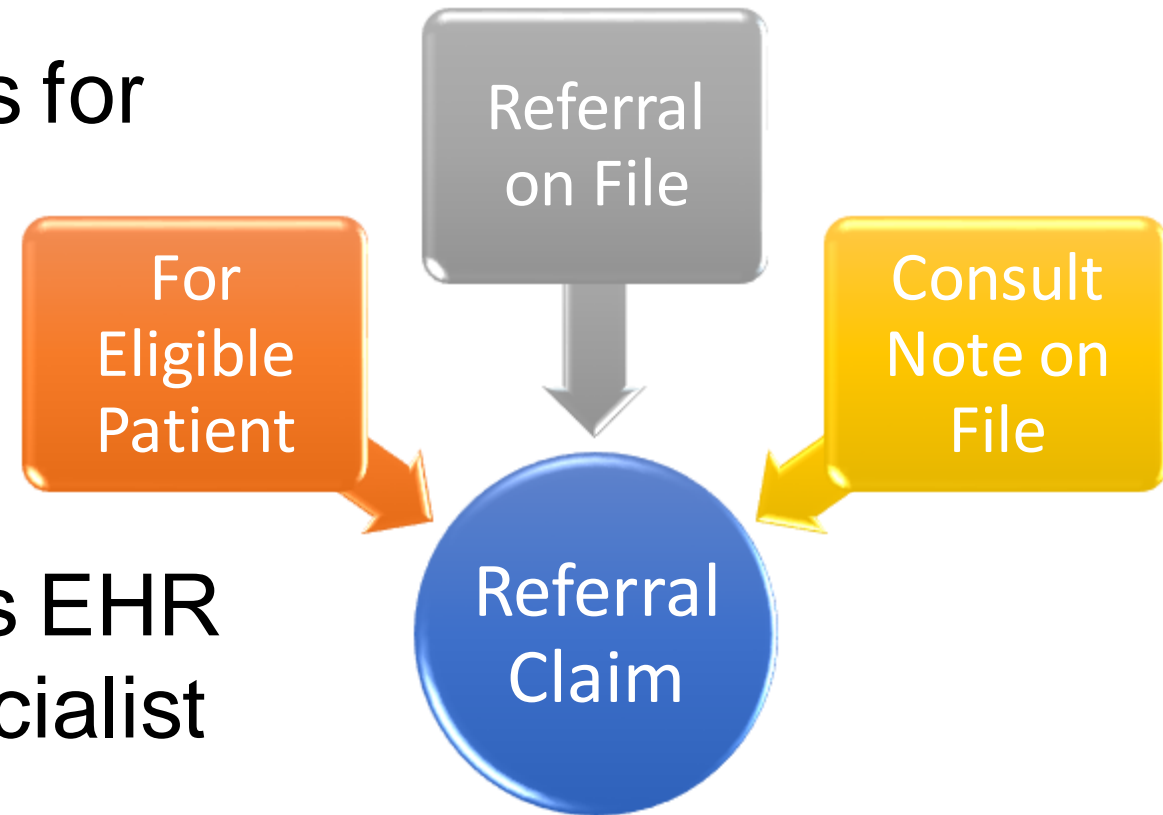
Where do the 340B savings come from?

Par80/CloudMed:

CloudMed Captures referral claims for CVS and Walgreens contract pharmacies

▪ **Eligible Referral Claim:**

- ✓ For an Eligible Patient
- ✓ Have a Referral/Note in Patient's EHR
- ✓ Have a Consult Note from a specialist in Patient's EHR



Summary

❖ The stated congressional intent of 340B in 1992 was “ to stretch scarce federal resources as far as possible, reaching more eligible patients and providing more comprehensive services.” its intent ties directly to HJA’s belief “everyone deserves quality healthcare and access to the resources they need to be healthy and well.”

Summary

❖ At HJAHC patients are **NEVER** turned away for inability to pay and that is possible because of savings that HJAHC receives through the 340B drug pricing program and its corresponding contract pharmacy agreements

Summary
